For these reasons, participant has been encouraged to take out insurance coverage sufficient to protect participants interests. Participant or, if a minor, participants parents or legal guardians, assume full personal responsibility for all injuries including death, and/or personal property damage which may occur either on the premises or while engaging in stable activities off premises. Off premise activities include any competitions in which stable employees are coordinating participants participation. As a condition precedent to utilizing these premises and participating in stable, pleasure or competition activities, on or off premises, participant agrees on behalf of participant and/or participants minor children and legal wards that participant or participants parents or legal guardians will not bring a claim or initiate litigation of any kind against R&R Stables, or it members, officers, trainers, barn managers, and/or employees or volunteers, or event sponsor or host (hereinafter "the released parties"), for any reason, including instances which allegedly involve the negligence of any or all of the released parties. Participant further agrees to indemnify stable, La Estancia II, LLC, Nina & WL Pointer 11420 Milton Thompson Road, Lees Summit, MO 64086 (hereinafter referred to as Premise Owner, Landlord), and or the released parties for any and all costs incurred by stable and/or the released parties and/or premise owners in defense of any claim brought against stable, premise owners, and/or the released parties by third parties, whether such claim arises on or off premises.
